Dear Beloved,

I am honored to be with you in this lovely community of the Lutheran Church of Our Redeemer. I am excited about our future together. Intentional Interim Pastors have the charge of helping a church discover their identity. We start with the past, remembering times of joy and of sorrow. There will be a time for healing. God willing, we will look to the future with hope and joy. My hope is we will learn to listen to what God is up to and calling us to do.

What are we doing when we hear scripture? During a bible study do you not search for God in the words you hear? Are you not looking for truth in the stories about Jesus the Christ? Last week we gave thanks for our baptism. Was this not a way to say yes we believe in the baptismal promise of eternal life? Surprisingly, thinking about eternal life for most people does not drive them to seek God. Many folks have shared with me that the thought of eternal life is not what sends them out to do good works, or to church. It is not what they think about when they identify themselves as a Christian. For most Christians it is a living relationship with others and with our church or by our personal understanding of what we believe about Jesus and faith. Do we search for God with the heart of understanding how God is working in our life? How much thought do we give to listening to God?

As individuals, and as community, and even perhaps within the larger culture, it will be to our good to recover and own our search for God. By doing so, by owning the fact that we listen and look for God, we are acknowledging and making space for the fact that God is more than we may have known and lived. We make space for the enlargement of our hearts. Because God has already found us, it is given to us to search for God and to find God. Searching implies packing up and leaving the familiar because only in so doing do we receive the new and the unfamiliar, new gifts from God and God's all-encompassing love. Therefore a time of Joy. It is a time for

deeper listening and searching. In a very real sense, searching for God is already to have found Him.

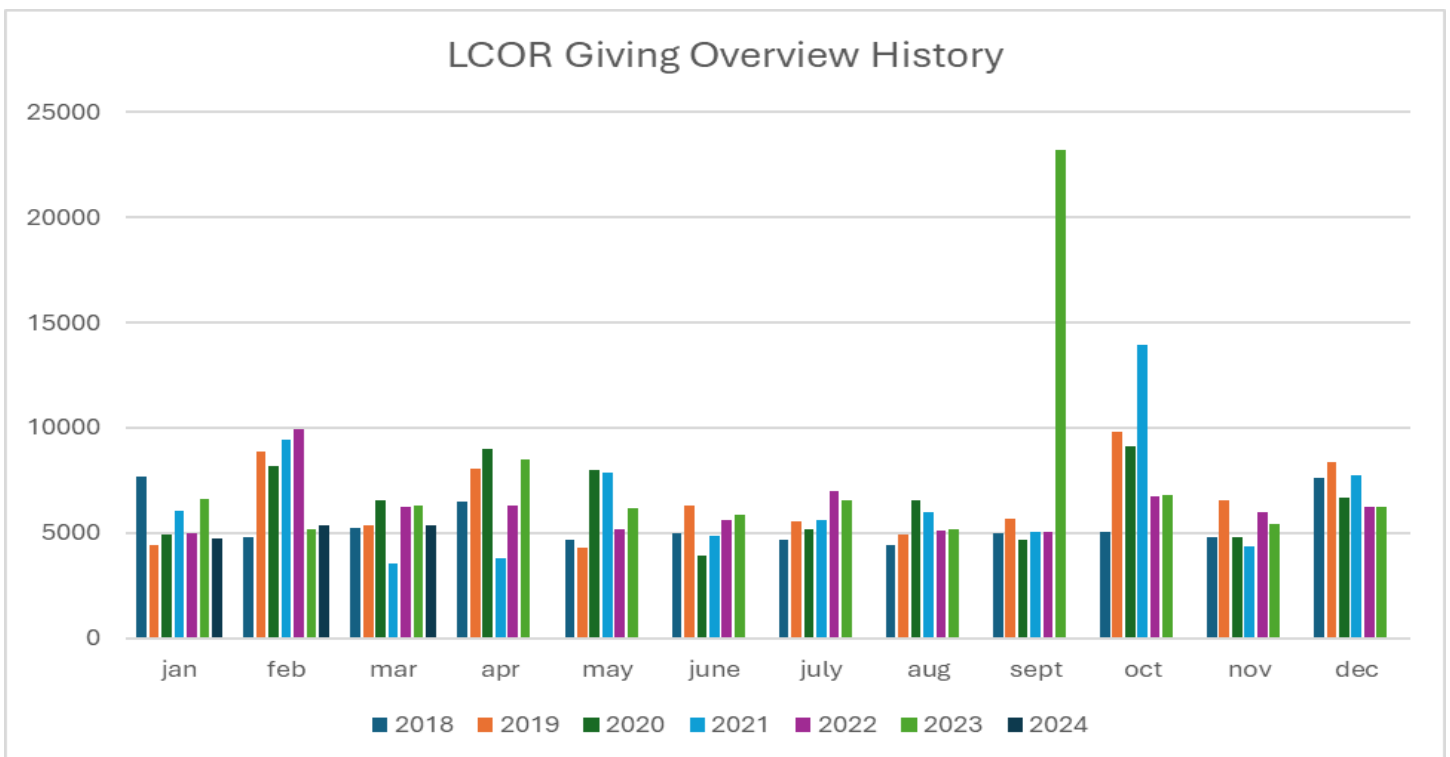

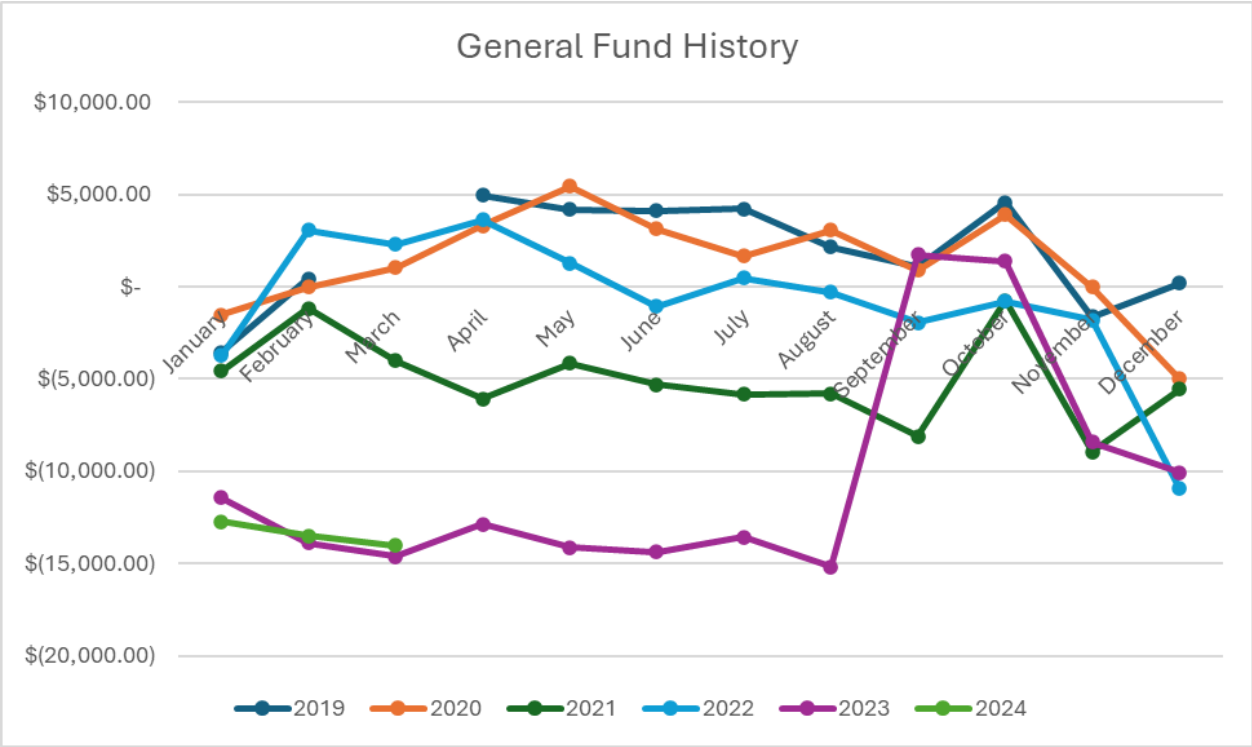
Included in this newsletter, you will find several charts depicting a history of LCOR's finances. These numbers are presented to and reviewed by council on a regular basis; however after the discussion at the special meeting of the congregation on April 7th and the questions asked, it was decided to share them with the entire congregation in the May newsletter in hopes of offering a clearer picture of our finances; where we've been as well as where we are today.

The monthly finance reports are reviewed and approved at each monthly council meeting. In addition, these reports are made available to the congregation in the notebook on the bottom shelf in the narthex. We strive for 100% transparency of funds, so if anyone has specific questions or would like to have further explanation, please feel free to attend a council meeting or just ask.

The general fund tracking will continue to be published in the newsletter. The general fund number is the difference in our actual cash on hand minus the special funds (money given for a specific purpose that has not yet been spent). If the general fund amount is negative, this means we are borrowing from our special funds to cover our bills – we are not borrowing from an outside source. The general fund is a cumulative number that changes with each expense paid and deposit made. If you have ideas for other information that you would like to see on a regular basis, please reach out to the treasurer or a council member and share your thoughts.

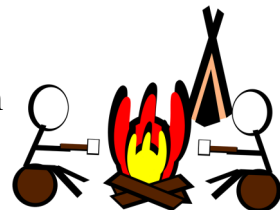
Thrivent Financial provided the "seed money" for this annual event. Edwards Right Price Market provided the sausage at a discounted price.

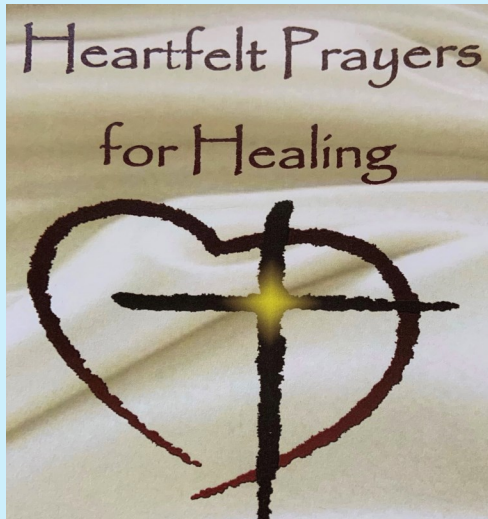

LCOR Special Council Meeting Minutes

April 4, 2024

Call to order at 5:07 pm. Council members present were Jeff Edwards, Karen Temple, Kay Johnson, Kay Carter. Also present were Terresa Lauck as finance officer.

The purpose of the special meeting was to ensure all members of the Church Council were on the same page with the proposed budget that would be presented at the Special Congregational meeting on April 7th, to answer all questions with regard to the budget and the hiring of Pastor Ruby Narucki, and to team build for the council.

Lots of discussion was held regarding the topics listed above. Council members received clarification on all the topics. There was consensus with the Council members on the proposed budget.

No votes were taken and no official action was taken. Meeting was adjourned at 6:25 pm.

LCOR Church Council Meeting Minutes

April 8, 2024

Call to order at 5:10. Council members present were Jeff Edwards, Karen Temple, Kay Johnson via Zoom, Kay Carter and Karen Liston. Also present were Terresa Lauck as finance and Eric Walek as a congregation member.

Opening Prayer- Led by Karen Temple

Approval of Agenda- Jeff moved to approve. Kay J. seconded; all approved.

Approval of Secretary Report- Jeff moved to approve. Karen L. seconded; all approved.

Approval of Treasurer Report-

Toner for the copy machine was purchased from the copy machine fund.

The men's group raised \$363.00 from the activities during Easter weekend.

The Youth account increased by \$9.20 from general interest.

Jeff voiced that he would like to see the financial fund in graph formation for the last five years to be shared with the congregation in the newsletter.

Two items were tabled for next month so they can be further investigated: 1) Eric Walek shared information from a conversation he had had with Sarah Moening from the synod office about possibly adding a donation for the Excellence in Leadership program to keep it going and to be affordable for people to be able to participate. 2) Serious conversation needs to be had in regard to the proposed boiler fund as it will be needing attention eventually, hopefully later than sooner.

Kay J. moved to approve the Treasurer Report. Jeff seconded; all approved.

Committee Reports-

Building and Grounds- Again plans to discuss the possible boiler fund at the May council meeting.

WELCA- No report was made.

Men's Group- The Men's Group was in charge of the bonfire evening at Elsie Menken's shop the Saturday before Easter and, also, the annual Easter breakfast before service. Both events were enjoyed by all who attended. Thank you to all of the men and those who helped them make the final events of Holy Week so enjoyable. The Men's Group made \$363 to be split between Rising Up and the Men's Group.

Old Business- Apartment Clean Out- Kay J. generously spent the prior Saturday cleaning up the little bits that needed to be taken care for the final check out after Pastor Liliana and Bruce and Pastor Michael moved out.

New Business-

Outdoor Project – Eric Walek- Eric reviewed that from the last group meeting held during a fellowship that no official group was formed, but that Pastor Liliana put Eric in charge. At that time, Rocky volunteered to have his students make

metal tables. Pastor Liliana had ideas for pavers, permanent seating, planters, and flowers.

Eric said that so far he has not heard any positive feelings being shared by congregation members about the project. There is concern about attracting people from the nearby businesses, especially those who smoke. Eric had called Pastor Liliana for some clarification on the length of time for the project to be completed. He shared that we have 3-4 years as a guideline for the entire project. Eric also voiced that he hoped for the EIL lesson of following critical mass idea to be the model to form a core team and to move the project forward.

Karen Temple shared that she, too, had contacted Pastor Liliana about the grant and the project. She clarified that the grant we received was for \$2,900 through the Rocky Mountain Synod. The stipulation for the grant is that the project has to be community minded. We do not have to show detailed evidence of the work and manner of spending the money. The Synod would prefer to have before and after pictures and a possible video compiled of the process.

Eric needs support with the forming of a team and spending the money.

He would like to get people to share ideas and suggestions with a suggestion box. He emphasized that we need to get an idea and then find out about the cost. The congregation is welcome to share any and all ideas for the project, however, the hope is to keep an open and positive mindset, especially during the idea collecting phase. It is hard to form plans if suggestions are only met with negative thoughts and dire predictions for the future use of the space.

We all agreed to set a goal for sharing the information with the congregation with the May and June newsletters. After collecting ideas and suggestions, the project can move forward from there.

Community Life Forum with Congregation- Karen T. suggested a potluck with a forum on April 21. Kay J. suggested having "different days" set for the forum to increase congregation communication. Pastor Ruby's first Sunday with LCOR will be on April 21. Karen T. suggested a welcome potluck on April 28 and will communicate with Francie and Pastor Ruby. Definite plans will be made when complete information is together as to what Pastor Ruby would also like to do.

Covenant Behavior Agreement- We talked about updating the agreements. Copies of the current Covenant Behavior Agreement will be given to the council this week and we can then discuss it in May.

We all agreed to set a goal for sharing the information with the congregation with the May and June newsletters. After collecting ideas and suggestions, the project can move forward from there.

Community Life Forum with Congregation- Karen T. suggested a potluck with a forum on April 21. Kay J. suggested having “different days” set for the forum to increase congregation communication. Pastor Ruby’s first Sunday with LCOR will be on April 21. Karen T. suggested a welcome potluck on April 28 and will communicate with Francie and Pastor Ruby. Definite plans will be made when complete information is together as to what Pastor Ruby would also like to do.

Covenant Behavior Agreement- We talked about updating the agreements. Copies of the current Covenant Behavior Agreement will be given to the council this week and we can then discuss it in May.

Active Member Roster- The Active Member Roster has been updated. There are currently 64 voting members on the list. This roster was used at the special congregation meeting that was held yesterday after church, with 23 people in attendance, including those on Zoom.

Kay J. suggested that since there is such a significant difference between the last update and the current roster that we look at the people who did not get on the current roster as those we can reach out to, a “care of the souls” idea. She reminded us of the conversation from last month about the formation of an Evangelism Committee and that this could be an opportunity to really check on people and not just send them a general letter from the synod about their membership status. We will address this topic again once Pastor Ruby is actively employed.

Constitution Update- Process- It was again agreed upon that the Constitution needs to be updated. We agreed that would be better when we have the guidance of someone with experience, such as Pastor Ruby.

Facebook- We need someone to be in charge of posting and keeping the information up to date on Facebook. The people who are able to post on the website has been updated. Karen L. shared that Stefanie L. asked about the use of Instagram along with Facebook, as they do not necessarily serve the same populations. Karen T. said we can look into cross posting from Facebook to Instagram so it would be consistent information. The ultimate agreement was to talk with Pastor Ruby to see what ideas she has and if she would like to take the lead on this.

Other Business-

Youth Funds- Karen L. presented a receipt for the materials she had purchased for the children’s Easter bags. Stefanie L., her friend, Chloe, Teresa, and Karen had a mini meeting about what to include in the bags. The ultimate decision was left to Stefanie and her friend. Karen requested reimbursement from the youth fund for the sum of \$62.01. Karen T. moved to approve. Jeff seconded; all approved.

Open Door Grant money- As we are nearing the deadline for using the funds LCOR received from the grant, it was suggested to check with the Synod to see if it would be agreeable to combine the remaining \$413.36 to the landscaping grant obtained by Pastor Liliana. Kay C. is looking to have all the Open-Door Grant materials to be able to see if it can be re-allocated to combine with the landscaping grant.

Council – The council decided and agreed to meet after the church service on April 21, 2024, to work with Pastor Ruby to finalize the specifics of her contract.

Apartment Clean Out- After Kay J. cleaned out the apartment for the final check, there were a couch and double bed left in the apartment that needed to be claimed by someone by Friday, April 12. They were offered free to anyone who would come and get them. Karen L. contacted a friend who works migrant and immigrant families. Her friend knew of two families who were in need. Jeff shared his truck. Jeff, his son, Karen’s friend, Francisca, and her husband, and Karen’s husband wonderfully volunteered to deliver the items. The two families were extremely thankful for the generosity and kindness shown to them. The other small items and a box were moved from the apartment to a Sunday school room at the church to be taken care of later.

Men’s Group- The amount of \$363 has been deposited into the Men’s Group account. The men will decide how to divide the money between their account and Rising Up.

Bulletin Board Suggestion- It was brought to the council that Delette Woodward suggested changing the bulletin board in the back of the church to have current activities and pictures. She expressed her gratitude that pictures of family members who have passed away was had been available, but she suggested that the change could be a part of the healing and moving on process for those family and friends of the loved ones. Everyone on council agreed that was a good idea.
